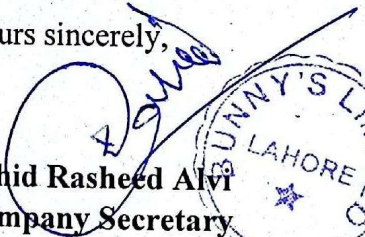

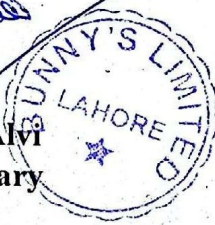
In this connection, we would like to clarify that the Company is not aware of any reason which has led to the increase in price of its share.
