NOTICE OF EXTRAORDINARY GENERAL MEETING

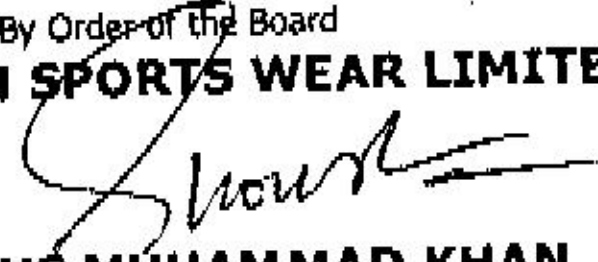
