The financial results for period ended September 30, 2017 compared with September 30, 2016 are as follows:

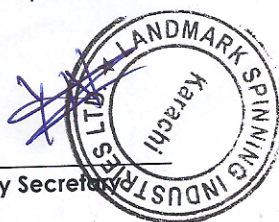

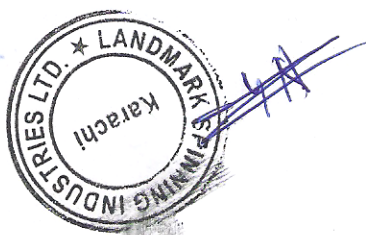
