This is in reference to applications received from Pakistan International Container Terminal Limited (the 'Company') on the above-noted subject; requesting extension of 30 days under section 132 read with section 223 of the Companies Act, 2017 (the 'Act') for convening of its Annual General Meeting ('AGM') for the year ended December 31, 2024 and under section 237 of the Act for filing of first quarterly accounts for the period ended March 31, 2025.

2.
