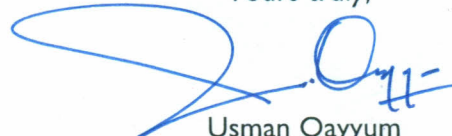
The financial results of the Company for the quarter ended September 30, 2018 are attached at Annexure-I.
