Please refer to the personal hearing held on February 14, 2019 in the office of Executive Director of Corporate Supervision Department of Securities and Exchange Commission of Pakistan (SECP) "here-in-after referred as Commission". In the personal hearing complete detail regarding delay in holding of Annual General Meeting (AGM) and circulation of quarterly accounts has been shared. Accordingly the Commission was requested to allow the Company to circulate its 1st quarterly accounts by April 15, 2019 and the same request was also submitted in writing vide letter dated February 11, 2019.

The auditors will require a reasonable time to complete the limited scope review of Half yearly accounts for the period ended December 31, 2018.

Keeping in view of the above facts and legitimate constraints of the Company, Commission is kindly requested to grant extension for the circulation of Half yearly accounts by April 30, 2019.

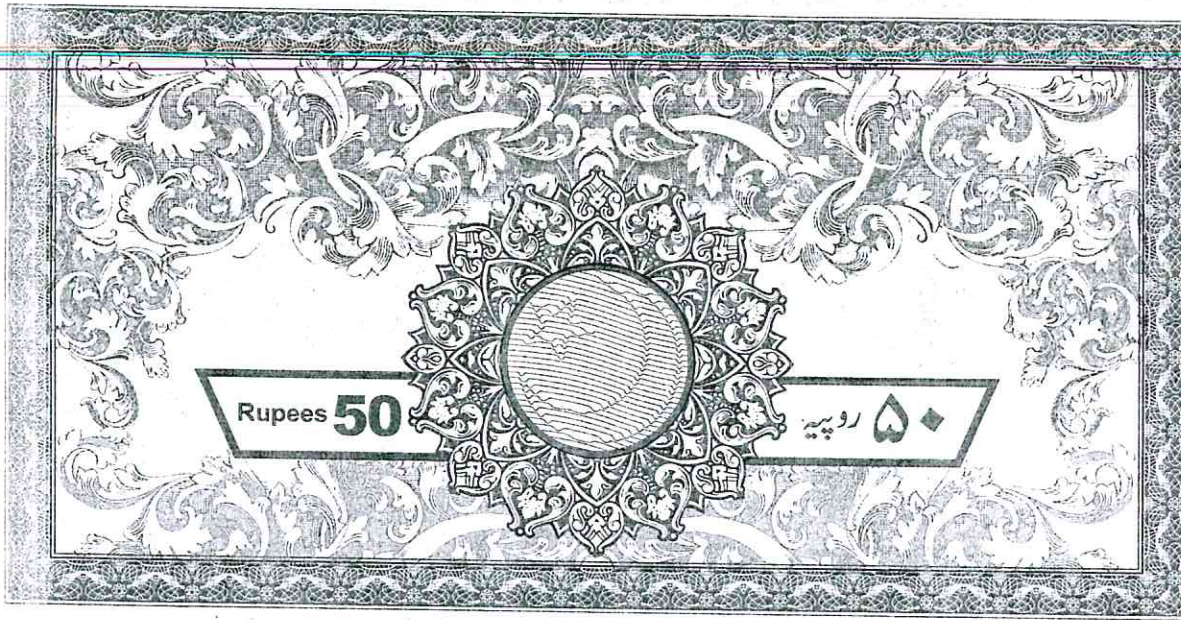
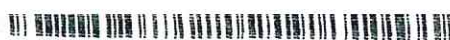

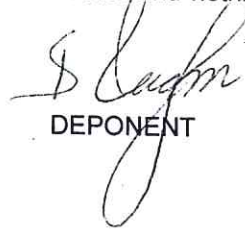
