Financial Results for the First Quarter (January - March), 2015

At its meeting held on 17 April 2015 at 15:00 Hrs at Karachi, the Board of Directors of the Company has approved the Condensed Interim Financial Information for the First Quarter ended March 31, 2015.

Sales grew by 9.5% on the back of innovations and strong brand equity. Gross Margin reduced by 104bps vs. same period last year due to adverse sales mix and costs incurred to strengthen formulations. Due to higher investment in innovations, EPS grew by 1%.

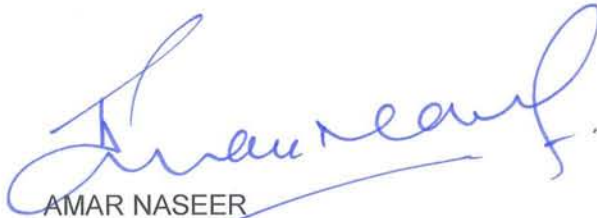
